**Purpose:** This program provides a forum to discuss current trends in the fields of interpersonal violence prevention and response, including evidence-based best-practices, such as utilizing culturally competent interventions as well as to highlight emerging areas of focus for the field, including exploring ways to effectively enlist men as partners in the fight to end violence against women. This program will explore ways to address these challenges for the purpose of providing victim-centered intervention and prevention services and promoting recovery from various forms of oppression including child abuse, domestic and intimate partner violence, sexual abuse, sexual harassment and sexual battery. This conference is relevant for those who work in law enforcement, child advocacy, mental health, victim services, domestic violence shelters, education, medical settings, the judicial system and for survivors and other members of the public who are concerned with these issues.

## Educational Objectives:

- To explain the struggles unique to those with lived experience of interpersonal violence in an LGBT relationship, and to identify on a broader scale how IPV affects mental health.
- To define LGBT and other communities that make up this under-served population, to give a brief historical perspective of the relationship between law enforcement and LGBT Communities and to discuss the need for law enforcement agencies to proactively work to overcome negative perceptions of law enforcement by the LGBT community.
- To identify the key aspects and people involved in a human trafficking investigation, and to list the best practices for law enforcement and victim service providers for collecting evidence, and ensuring a victim centered approach.
